

The Port Clinton Artists' Club invites you to apply to participate in *Arts in the Park*. The show is set on the wooded grounds of [Lakeview Park](#), across from Lake Erie in Port Clinton, Ohio.

**To apply, please read these instructions thoroughly, then complete, and return Application Form with your Entry Fee payment. Applications will be accepted until the show is full or until July 1, 2018, whichever comes first. The show has been full in recent years, so please apply early.**

- ⌘ We will be separating fine and craft art this year, as requested by many vendors. If you have participated for many years, your site location may change. There are no guarantees you will be in the same area as in previous years. The new map will not be available until closer to the show.
- ⌘ Per the City of Port Clinton, there will be NO parking allowed on the grassy areas after set-up. The parking areas at the front and rear of the show are for **GUESTS** only. As in the past you will need to move your vehicles to the designated areas, which is east of Lakeview Park on Rt 163 behind ACE Hardware.

**General Information:** More than 100 artists will display and sell their original works. Demonstrations are encouraged. There is no rain date. Food vendors must have a Health Department permit (see below), and art vendors should have an Ohio Transient Vendor License. You'll hear from us in July about your acceptance to the show and your site number. Vendors are NOT permitted to bring animals.

**Eligibility:** Original works of art only. **ALL applicants must submit three (3) close-up photos of art at the time of application, even if you are a returning artist.** Photos won't be returned and may be used for publicity purposes. The PCAC Review Committee reserves the right to refuse any application and return the applicant's Entry Fee. All items must be self-made by the vendor. **ABSOLUTELY NO** manufactured, commercial, wholesale, or offensive material will be permitted.

**Entry Fee:** A 15' by 15' site is \$120. **Sites 22, 95, 100, 111 and 112 are 15' x 20' and are \$175.** Please make check payable to **Port Clinton Artists' Club**. You will receive confirmation verifying your registration and site assignment in July.

**Site Information:** You will receive site number confirmation in July. Electricity is not available. Vendors **must** provide all display furnishings and protection from the elements of weather. Vendor assumes full responsibility for loss or damage to person or property.

**Show Awards:** We will award **Best in Show** and **People's Choice**, as well as awards in the categories listed. Artists can be judged in only **ONE** category. Categories were chosen based on past show data. All artists will be evaluated for the Best in Show award.

**BEST IN SHOW & PEOPLE'S CHOICE** – Winners receive ribbon and free site for Arts in the Park 2018. Winners of categories below will receive an award ribbon.

1. Ceramics
2. Painting /Drawing
3. Glass
4. Jewelry
5. Mixed Media (single work, two or more media, height/width/depth, ie sculpture)
6. Misc. Art/Crafts
7. Photography
8. Textiles/Fiber Art
9. Wood

**Check-in/Set-up:** Vendors must check-in during these hours: Friday, August 3<sup>rd</sup> from 6 p.m. until 8 p.m. **or** Saturday, August 4<sup>th</sup> from 7 a.m. until 9:30 a.m. at the PCAC tent. Vendor vehicles are not permitted on the Show grounds after set-up. Displays must remain up and open to the public until 4 p.m. Sunday.

**Prepay for 2018:** Save money by prepaying during the 2017 event for 2018. Your check-in packet will contain a 2018 prepay registration form. The prepay cost is \$110 per 15' x 15' site and \$165 for a 15' x 20' site and must be paid by end of show on Sunday, August 5th. No exceptions.

**Food:** Food vendors will be available throughout the grounds. **ALL FOOD VENDORS MUST HAVE A LICENSE/PERMIT AND SHOULD CONTACT THE OTTAWA COUNTY HEALTH COMMISSIONER'S OFFICE AT (800)788-8803.**
