**The Port Clinton Artists' Club** invites you to apply to participate in ***Arts in the Park***. The show is set on the wooded grounds of Lakeview Park, across from Lake Erie in Port Clinton, Ohio.

**Saturday AUGUST 1, 2026 (10am-5pm) and Sunday AUGUST 2, 2026 (10am-4pm)**

**To apply, please read these instructions thoroughly, then complete, and return the application form with your entry fee payment. Applications will be accepted until the show is full or until July 1, 2026, whichever comes first.**

**General Information:** More than 100 artists will display and sell their original works. Demonstrations are encouraged. There is no rain date. Food vendors must have a Health Department permit (see *Food* below), and art vendors must have an Ohio Transient Vendor License. Vendors are encouraged not to bring animals. If you must bring your four legged side kick, please reach out at [artsintheartportclinton@gmail.com](mailto:artsintheartportclinton@gmail.com) to alert the Show Director.

**Eligibility: Original works of art only.** All items must be self-made by the vendor. ABSOLUTELY NO manufactured, commercial, wholesale, or offensive material will be permitted. ALL applicants must submit three digital close-up photos of art at the time of application. The PCAC Review Committee reserves the right to refuse any application and return the applicant's entry fee.

**Entry Fee:** A 15' by 15' site is \$130. Please make a check payable to **Port Clinton Artists' Club**. Payment online is through the [Port Clinton Artists' Club](#) under Arts In the Park heading.

**Site Information:** You will receive site number confirmation in mid July. Electricity is not available for Art Vendors. Portable generators for Food Vendors will require permission from the Show Director. Vendors **must** provide all display furnishings and protection from the elements of weather. Vendor assumes full responsibility for loss or damage to person or property.

**Show Awards:** All artists will be evaluated for the ***Best in Show*** award. The Best in Show winner receives a free site for Arts in the Park 2027. In addition, artists' work will be judged according to the following 11 categories and winners receive ribbons. Artists can be judged in only **ONE** category.

1. Ceramics	6 Mixed Media
2. Painting/Drawing	7. Misc. Art/Crafts
3. Glass	8. Photography
4. Jewelry-Assembled	9. Textile/Fiber Art
5. Jewelry-Handcrafted	10. Wood-Painted
	11. Wood-Furniture, Turned, Hand Carved

**Check-in/Set-up:** Vendors **must check-in** at the PCAC Registration Tent during these hours: Friday, July 31 from 4 pm until 8 pm **or** Saturday, August 1 from 7 am until 9:30 am. **Vendor vehicles are not permitted on the show grounds after set-up.** Displays must remain up and open to the public until 2 pm Sunday. **No vehicles on show grounds until after 2 pm Sunday.**

**Per the City of Port Clinton, there will be NO parking allowed on the grassy areas after set-up. The parking areas at the front, rear and streets around the park are for GUESTS only.** As in the past, you will need to move your vehicles to the designated area near the intersection of East 2<sup>nd</sup> and Maple Streets. Shuttle service will be provided to parking areas. **Please call 760-895-0759 for pick-up.**

**Food:** Food will be available on the grounds. All food vendors must have a license/permit and can contact the Ottawa County Health Commissioner's office at (800)788-8803.

**Vendors failing to abide by our regulations may not be accepted to the show in 2027.**
